A motion was made by Kevin Avery to approve the consent agenda items two through eight. Victoria Dougharty seconded the motion, and the Board unanimously approved the consent agenda.

Dr. Keiser, Executive Director, updated the Board on COVID-19 & Monkeypox.

Ami Cotharn, Chief Operating Officer, presented the July 2022 Coastal Wave. Ami informed the Board of the Back-to-school block party Saturday, July 30<sup>th</sup> from 10a.m. to 12p.m.

Ami Cotharn, Chief Operating Officer, updated the Board on clinical operations.

- Coastal Health & Wellness has four new hires.
  - ➤ Medical Assistant, LVN, RN and Outreach Eligibility and Enrollment Manager.
- Two outreach events scheduled for the month of July.
  - ➤ Back-to-school block party event
  - ➤ Hitchcock resource round up

Coastal Health and Wellness has had an increase of about 200 new patients per month.

Hanna Lindskog, updated the Board on dental services in the Coastal Health & Wellness Clinic:

- The dental clinic continues to follow CDC's Interim Infection Prevention and Control Recommendations for Healthcare Personnel which has a section dedicated to Dental Facilities. We are wearing N95 respirators for all aerosol generating procedures.
- The College of the Mainland Dental Hygiene Program hired their new program director. We have our next Advisory Board meeting on August 30<sup>th</sup>, 2022. We look forward to continuing to build our relationship with their program.
- We have continued to use the modified scheduling template to allow for an additional treatment/procedure spot every day, as well as a designated comprehensive exam slot every day for each provider. The dental hygienists also have pediatric comprehensive exams on their schedule. The current wait list is at 608 people, which is 83 more than reported last month. We are working on a way to simplify the wait list with NextGen to remove the possibility of duplicate entries. Patient Services staff has been working hard to schedule the patients on the waiting list. In the month of June, we completed 62 comprehensive exams on new patients. As reported previously, we have "new" acute appointments available to address immediate needs so that no one in pain is waiting. We had a total of 212 Acute visits in the month of June. 74 of those patients were either new to our clinic or had not been here in over 3 years. In the month of June, 153 extractions and 245 restorative procedures were completed.
- We expect a drop in patient visits in July due to multiple dentists having unplanned absences due to COVID, but we are thankful to report that everyone is back and healthy.
- Our application was selected for the NNOHA Teledentistry Collaborative. This will be a virtual collaborative and will involve participation from several dental clinic staff members including one of our full-time staff dentists, Dental Director, and Dental Assistant Supervisor.
- At the last board meeting Dr. Southerland recommended speaking with the Diabetes course instructor to verify Oral Health was part of the curriculum. It was discovered that Oral Health is only briefly mentioned. Dr. Lindskog is working with Shannon Lindsey to enhance the curriculum as it relates to Oral Health.
- We have committed to attending several outreach events in the community.
  - o July 30<sup>th</sup> CHW Back to School Fair
  - October 21st City of Texas City Senior Program at Nessler Park (dental presentation and handout for Seniors – Dr. Lindskog)

#### CHW is committed to providing safe dental visits

Coastal Health & Wellness is excited to celebrate Dental Infection Control Awareness Month in September and highlight our commitment to provide patients safe dental care.

This year's theme is "Staying in the Know Together".

While we perform many infection control procedures behind the scenes, we want you to see four important ways we keep you safe:

- Clean hands: We comply with the CDC's hand washing and glove handling guidelines. See how we wash (or use alcohol sanitizers on) our hands and don new gloves for each patient.
- Sterile tools: We carefully follow all the steps for instrument processing, so you get clean, sterile instruments every time.
- Safe water: We treat the dental unit waterlines to ensure the water going into your mouth meets federal guidelines and is safe for you.
- Patient eye protection: We comply with the CDC's recommendation for patient eye
  wear protection to protect your eyes.

One of the best things people can do to prevent the spread of infection is to wash their hands thoroughly and frequently. Germs can't resist sterilization - that's why we sterilize our instruments. The disinfectants we use to wipe down surfaces are effective against COVID-19 as well as other viruses.

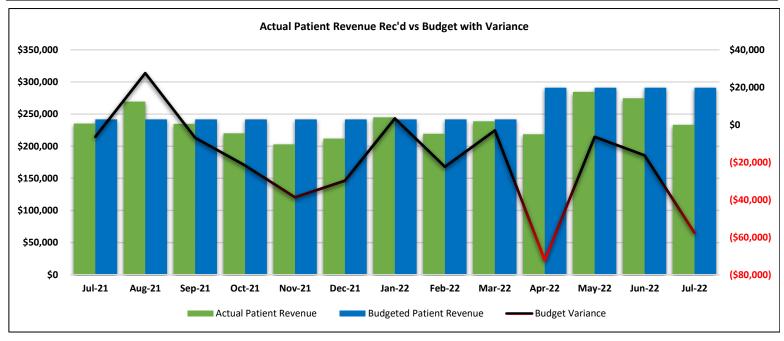
Revenue: MTD revenue higher that budget due to higher HHS grant revenue, which offsets DSRIP revenue and losses in Patient Revenues. YTD revenue is slightly higher due to increased HHS Grant Revenue, which offsets DSRIP Revenue and below budget Patient Revenue. Pharmacy revenue is down due to payback for overpayments made earlier in the year for Prep Rx's. HRSA Base Grant and ARP grant currently do not have enough expenses being applied, and a true-up for these grants needs to be done.

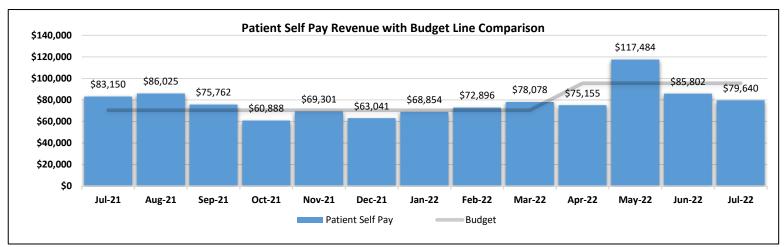
Expenses: MTD expenses overbudget due to increase in Personnel expenses, Contractual expenses, Bad Debt and Other (Professional and

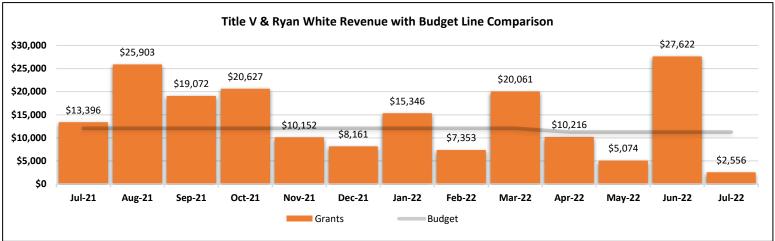

- Total Fund Balance is \$8,120,796 as of 07/31/2022.

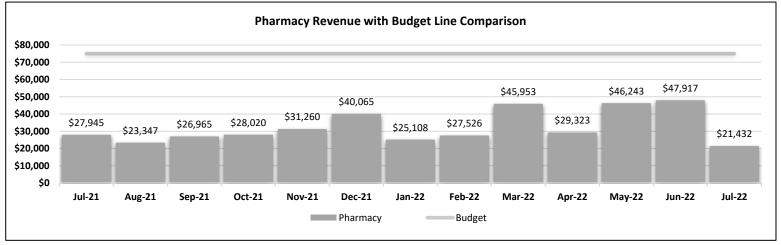


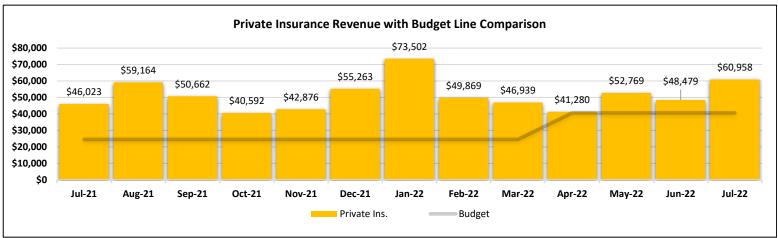


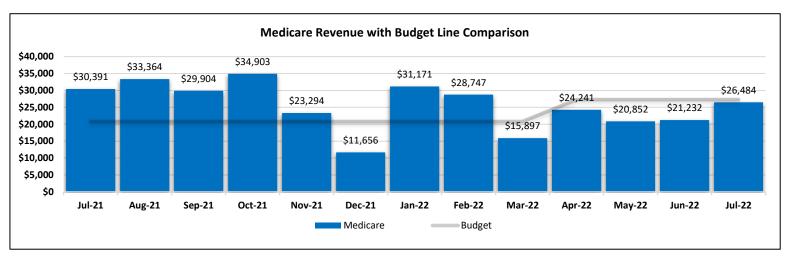


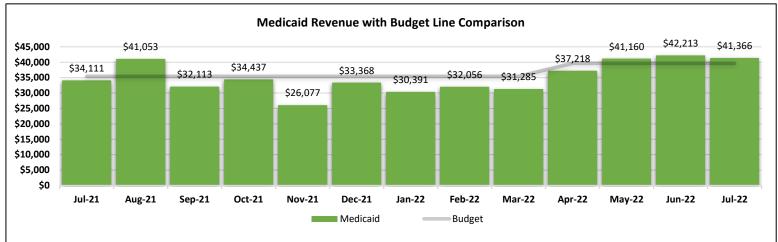


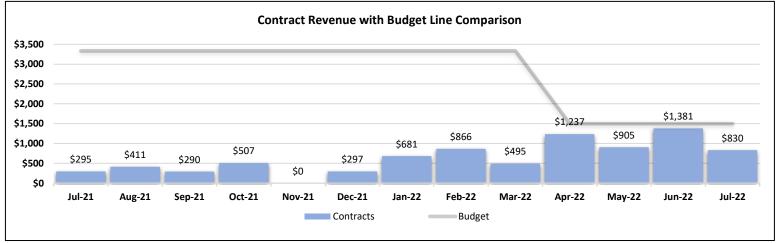


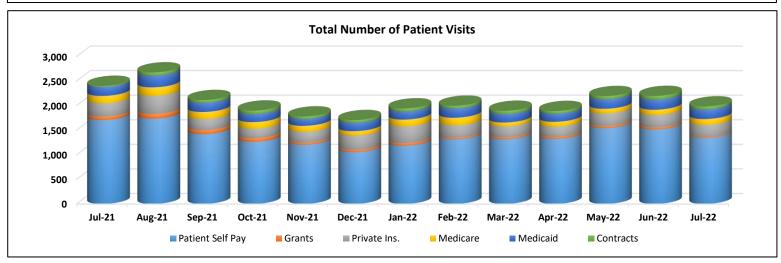












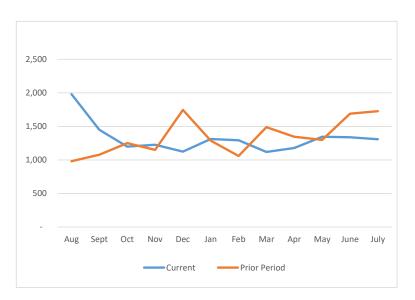

## Consulting Assistance to Improve Revenue Cycle Management Productivity

#### **Essential Requirements:**

- Take actionable steps during this process. Avoid spending time on reporting issues, instead spend time on creating improvements.
- Assess strengths and weaknesses of RCM staff, processes, and financial productivity (gap assessment).
- Document current and future workflows for RCM.
- Review current Policies and Procedures, identify gaps and provide recommended documents (using HRSA 2022 recommendations and regulatory requirements).

## Step 1 - Onsite Visit with Consulting Team August 16-18th

- Key staff were interviewed and current workflows captured.
- Issues facing the Billing department were explored with detail on prioritizing tasks.
- Initial billing financial productivity analysis was explored with senior leaders, however was not shared with general staff at this time.
- A substantial review of the outsourced billing company processes and reports was done.
- A relationship was made with Jonathan to assure he was involved in all processes and agreed to be they key person to help document and implement best practices in the department.



## Three (3) Initial Priorities Identified, Agreed to and Action Underway

- 1. Our largest potential for revenue increase is to begin an enrollment project to help all Self Pay and Sliding Scale patients obtain Medicaid.
  - Most Self Pay/Slide revenue is written off today. With Medicaid, those visits will yield \$179 per visit and the patients will have less copays.
  - Other Texas centers have a plan to help enroll the patients.
- 2. The next revenue potential is to "go fully electronic" for all authorizations, claims, payments, and improve statement and text message process.
  - They are no electronic payments today causing check management by staff, copying, balancing, and sending to the Billing Company to manually post to the system. Additionally the Billing Company is not posting denials, hence we cannot report on denial trends or repairs.
  - This requires review of current electronic data interface (EDI) and obtain other quotes to assure we are fully using the systems, at the best price.
- 3. The third priority is to document all tasks that are required for reporting and billing management.
  - This process includes capturing tasks by all staff and the tasks being performed by the Billing Company to assure we are able to manage the productivity of the entire process.

### Next Steps

- Resolve largest issues causing non-payment of claims. Document the appropriate coding and billing going forward.
- Design the future workflows with better claims and payments management.
- Create daily "duties with expectations" to organize the staff and move from putting out fires to forward planning for issues.
- Create an "our payer bible" to document every special detail of billing for that payer by department (dental, medical BH, women's care)
